General principles

We accept complete responsibility for our business actions in the environment in which we operate - to our employees, business partners and the general public. Therefore, we have established principles and ground rules of conduct and behaviour that are central to our business activities.

We are governed by the laws of the Czech Republic, the European Union and the laws of other countries where we do business. Compliance with legal norms and rules and acting in accordance with the legal order of the Czech Republic is a fundamental norm for our company. In addition to the directives and regulations in force at Grant Detection, s.r.o., all employees are required to act in accordance with the laws of the Czech Republic or other countries where our company operates. Violations of the law must be prevented at all times.

We always conduct our business according to high moral and ethical standards. We are open, honest and accept our responsibilities. We are reliable partners and do not make promises we are unable to keep. We bid for contracts in an honest manner by offering quality and value for money, not by offering undue advantages.

We respect the Universal Declaration of Human Rights, the International Covenant on Civil and Political Rights and the International Covenant on Economic, Social and Cultural Rights, the eight fundamental conventions of the International Labour Organization (ILO). We respect the dignity, privacy and personal rights of every individual. We do not tolerate discrimination of any kind against any individual. These principles apply both to internal cooperation and to dealings with external partners. Decisions about our collaborators - including employees, suppliers, customers and business partners - are made only after due consideration, and are not based on improper considerations such as discrimination or coercion.

We maintain confidentiality. About confidential or proprietary internal information Grant Detection, s.r.o. must be kept confidential. We respect the protection of personal and business data. In accordance with legal and contractual requirements, we ensure the protection of information relating to, or information provided by, suppliers, customers, employees, agents and other third parties.

We ensure accurate, truthful and transparent reporting. This rule applies equally to relations with employees, customers and business partners as it does to dealings with the public and all government bodies.
